Matters under the jurisdiction of the Committee and not on the posted agenda may be addressed by the public following completion of regular business matters. The Committee limits testimony on matters not on the posted agenda to five minutes per person and not more than fifteen minutes for a particular subject.

SUBJECT:

Sacramento County Consolidated Oversight Board Appointment

Sacramento County Successor Agency staff is recommending that the City Selection Committee make an appointment to the Sacramento County Consolidated Oversight Board (Countywide OB) at the Committee's meeting of May 3, 2018.

Pursuant to Health and Safety Code Section 34179 (j), on and after July 1, 2018 in each county where more than one oversight board was created, there shall be only one Countywide OB. The Countywide OB shall be staffed by the Sacramento County Auditor-Controller (CAC), by another county entity selected by the CAC or by a city within the county that the CAC may select after consulting with the California Department of Finance. The successor agencies of the following cities, effective May 3, 2018, will report to the Countywide OB: City of Sacramento, City of Folsom, City of Galt, City of Isleton and City of Rancho Cordova.

Pursuant to Health and Safety Code Section 34179 (j)(2), one member of the Countywide OB may be appointed by the City Selection Committee established pursuant to Section 50270 of the Government Code. The term length of the appointment is indefinite because the Countywide OB will remain in place until each successor agency within the County has been formally dissolved pursuant to Health and Safety Code Section 34187.

The Sacramento County Successor Agency staff and the Sacramento County Clerk of the Board's Office are working together on behalf of the CAC to organize the consolidation process for those oversight boards within the County of Sacramento. Once an appointment is made, the Clerk of the City Selection Committee will notify the Board of Supervisors by memorandum as an informational item on the next available agenda.
