Ad Hoc Committee To Build A Friends of the Commission

March 25, 2021 6:00 pm – 7:00 pm

I. Recap of Current BRC + Commission Status:

- Applications are officially open for BRC Members!
- BRC staying in place until the official women's commission is fully seated

II. Discussion of Structure for Future 'Friends of the Commission'

- We will move toward a formal nonprofit status (501(c)3): Lee, Carol, and PJ are coming up with a list of the steps we need to complete to make this happen
- We will ask the SF 'Friends of the Commission' if they have by-laws we can review and use for our purposes Erin
- Ideas for names: "Friends of the Sacramento Women's Commission" (keep "commission" in there so it's clearly connected)
- Erin will reach out to Sacramento Women Lawyers for additional feedback on the 501c3 process. Should cost about \$200 to file for nonprofit status but we will check on this.
- Tonya would like to attend an SF 'Friends of the Commission' meeting to see what their process and meetings are like

- Re: structure: we may eventually want a paid administrative position, maybe an ExecutiveDirector? We will discuss once we have more clarity about SF's by-laws

III. Discussion of Timeline

- The nonprofit process takes about 2-3 months, so we will start it now and hopefully finish by the time the Commission is officially seated, at which point the BRC can be archived.
- We can potentially utilize BRC + Sacramento For Women and Girls funds (about \$4k left) to fund some of the messaging and graphics we will need to communicate with public about the transition
