**PURPOSE:** The purpose of the Citizen's Advisory Committee (CAC) is to establish and maintain community relations regarding issues involving local state prisons and the surrounding communities. The primary objectives of the CAC are to improve the public's understanding of correctional programs, influence correctional directions and suggest means to improve and participate in inmate programming.
