Overview

The Political Reform Act requires governmental agencies to identify and designate those positions and offices within the organization which are subject to disclosing potential conflict of economic interests. On August 11, 2015, the Board approved the Conflict of Interest Code (COI Code) of the Boards, Committees, Commissions and Councils (BCCC). The COI Code of the BCCC identifies BCCCs and designated positions that are required to file a Statement of Economic Interests (Form 700). Subsequent to the adoption of the COI Code of the BCCC there have been significant changes to the item. Further, the Board approved the removal of appointed members to BCCCs that fail to file a Form 700 statement within a prescribed timeframe or fail to complete the required Ethics training pursuant to Assembly Bill 1234 (AB 1234). However, a process was not defined for those members wishing to reapply for consideration of appointment to a BCCC upon meeting the requirements. Therefore, a proposed process has been established for the Board's consideration.

Recommendations

- 1) Adopt the attached resolution amending the COI Code of the BCCC assigning consistent filing disclosure categories to Community Planning Advisory Councils (CPACs), clarifying disclosure categories for specified BCCCs, providing positions with designated names, deleting specified BCCCs as designated positions required to file Form 700 statements under the COI Code of the BCCC, and removing jointly governed BCCCs that use a COI Code other than the County's.
- 2) Adopt the attached resolution to amend the County policy mandating ethics training for appointed members to a BCCC pursuant to AB 1234 and to establish a process for reapplication.

Measures/Evaluation

The amended COI Code of the BCCC will reflect current positions that are required to file a Form 700 under the appropriate disclosure categories. It will foster a process that facilitates

ethical standards being upheld and within compliance under the provisions of AB 1234 and of Government Code §53232 (et seq.).

Fiscal Impact

Approval of the recommendations will have no fiscal impact to Sacramento County or the General Fund.

BACKGROUND

The Political Reform Act requires governmental agencies to identify and designate those positions and offices within the organization which are subject to conflict of interest disclosure. The Board of Supervisors makes appointments to the BCCCs. There are designated positions that are required to file a Form 700 when assuming office, annually while in office, and when leaving office.

On September 23, 2014, the Board approved the purchase of an electronic filing system, endorsed by the Fair Political Practices Commission (FPPC), to provide more efficient management of the Form 700 filing process. This system currently includes the electronic filing of Form 700 statements by employees who are designated to disclose economic interests. In January 2016 there will be approximately 1,300 additional filers of the BCCCs and Special Districts submitting electronic Form 700 statements.

Per Government Code section 87302, the County is required to review its COI Code biennially. In August 2015, the Board approved amendments to the County's COI Code of the BCCC and stated that failure to submit a Form 700 within 30 days of assuming office would constitute resignation from the BCCC, effective immediately, and would deem the position vacant.

On July 18, 2006, the Board adopted Resolution No. 2006-0877 approving a policy requiring Ethics training pursuant to AB 1234 which requires all elected officials of the County and all members of the County's "legislative bodies" to complete a minimum of two hours of Ethics training. In August 2015, the Board required all filers appointed to a BCCC to complete Ethics training and that failure to complete the required training would be subject to "good cause" for removal from the BCCC.

DISCUSSION

The purpose of the recommended revisions to the COI Code of the BCCC is to assign consistent filing disclosure categories to all CPACs, to clarify disclosure categories for specified BCCCs, to provide positions with designated names, to delete specified BCCCs as designated positions required to file Form 700 statements under the COI Code of the BCCCs, and to remove jointly governed BCCCs that use a COI Code other than the County's.

It was determined by County Counsel that all CPACs should be required to disclose potential conflicts under disclosure categories A and B. Disclosure categories A and B are defined in the attached revised COI Code of the BCCC (Attachment 1). It was discovered that the Antelope CPAC was not consistent with this designation and the revised COI Code of the BCCC now reflects the appropriate disclosure categories for the Antelope CPAC.

Further, the County's Planning Commission and four CPACs identified as Planning Commissions (Arden Arcade, Carmichael/Old Foothill Farms, Fair Oaks, and Rio Linda/Elverta) are required to fully disclose economic interests per FPPC regulations pursuant to Government Code 87200. Currently, the categories do not reflect this designation and need to be clarified within the County's COI Code of the BCCC. Exhibit C (Attachment 3) of the COI Code of the BCCC lists the positions required to file statements of economic interest per Government Code Section 87200.

Currently, four BCCCs (Sacramento Transportation Authority/Sacramento Abandoned Vehicle Service Authority, Paratransit, Inc. – Board of Directors, Carmichael Recreation and Park District, and Galt-Arno Cemetery District) are included in the County's COI Code of the BCCC, even though they are governed jointly by the Board of Supervisors and other elected boards and thereby are filing Form 700 statements pursuant to a separate COI Code respectively. These jointly governed BCCCs are not required to disclose economic interests prescribed by the County's COI Code of the BCCC, and these BCCCs need to be removed from the Code of the BCCC. Attachment 4 lists the BCCCs not required to file under the COI Code of the BCCC.

The Children's Coalition currently has 30 positions on the BCCC (Attachment 2, Page 8). Positions 13 through 30 are designated as Interest Area Category Seats. Currently the COI Code of the BCCC does not reflect this designation, and some seats are not assigned a position name. Clarifying this on the Code of the BCCC would allow for an efficient process to manage the filers assigned to these positions.

The Board has determined when an appointed member to a BCCC fails to file a Form 700 within 30 days of appointment, this constitutes as a resignation and the seat is declared vacant. Similarly, when an appointed member fails to complete the required Ethics training, the member is subject to being removed from the BCCC. Currently, a process has not been defined for members who wish to reapply to the BCCC upon completing the requirements set forth in Resolution Nos. 2015-0616 and 2015-0617. Therefore, when a member has been removed from the BCCC as a result of failing to file a Form 700 or failing to complete the required Ethics training by the required deadline and wishes to reapply to the BCCC, it is being recommended that in addition to submitting the Form 700 or completing the Ethics training, the member must complete the application and interview process and be nominated by the Board for appointment to the BCCC.

The intention of the recommendations is to maintain uniformity of policies and compliance with FPPC regulations. All BCCC filers shall file Form 700 statements with their assigned filing official. The Clerk of the Board shall receive original statements and maintain records of original statements per FPPC regulations for all filers excluding 87200 filers. No further amendments to the COI Code of the BCCC were needed beyond the recommendations stated above.

After careful analysis of the proposed recommendations conducted with County Counsel, amendments were made to the COI Code of the BCCC and its Exhibits and are reflected in Attachments 1, 2 (Exhibits A and B), 3, 4 and 5. Attachment 6 includes a strikeout version of Attachments 1 through 5.

County Counsel has reviewed and approved all attachments.

MEASURES/EVALUATION

The amended COI Code of the BCCC will reflect current positions that are required to file a Form 700 under the appropriate disclosure categories. It will foster a process that facilitates ethical standards being upheld and within compliance under the provisions of AB 1234 and of Government Code §53232 (et seq.).

FINANCIAL ANALYSIS

Approval of the recommendation will have no fiscal impact to Sacramento County or the General Fund.

RESOLUTION NO. 2016-0017

APPROVING AMENDMENTS TO SACRAMENTO COUNTY'S CONFLICT OF INTEREST CODE OF THE BOARDS, COMMITTEES, COMMISSIONS, AND COUNCILS DELETING AND AMENDING COMMITTEES

WHEREAS, the Political Reform Act requires governmental agencies to identify and designate those positions and offices within the organization which are subject to conflict of interest disclosure; and

WHEREAS, per Government Code §87302, the County is required to review its Conflict of Interest Code biennially; and

WHEREAS, the County of Sacramento has undergone organizational changes modifying or eliminating Boards, Committees, Commissions and Councils; and

WHEREAS, California Code of Regulations §18730 authorizes the County to incorporate by reference the terms of the regulation along with the designation of Boards, Committees, Commissions and Councils and formulation of disclosure categories appended to the regulation, and thereby comply with the requirement to adopt and promulgate a conflict of interest code.

WHEREAS, incorporation by reference of the aforementioned regulation in Conflict of Interest Codes will save this body time and minimize the actions required of this body to keep the Codes in conformity with the Political Reform Act.

BE IT NOW THEREFORE RESOLVED AS FOLLOWS:

- 1. The County of Sacramento Conflict of Interest Code of the Boards, Committees, Commission or Council as adopted pursuant to Resolution No. <u>1990-1347</u>, is hereby repealed.
- 2. The terms of California Code of Regulations §18730 and any amendment thereto, are hereby incorporated by reference and constitute the Conflict of Interest Code of the Boards, Committees, Commissions and Councils of Sacramento County as supplemented by Paragraphs 3, 4, 5, 6 and 7 below and Attachment 1 and 2 (Exhibits A and B) as amended and attached hereto and incorporated herein.
- 3. Exhibit A of the Conflict of Interest Code is herein amended to delete Arden Arcade Community Planning Advisory Council, Carmichael Recreation and Park District, Carmichael/ Old Foothill Farms Community Planning Advisory Council, County Planning Commission, Fair Oaks Community Planning Advisory Council, Galt-Arno Cemetery District, Paratransit, Inc. Board of Directors, Rio Linda/Elverta Community Planning Commission, and the Sacramento Transportation Authority/Sacramento Abandoned Vehicle Service Authority; amend the Children's Coalition seat numbers 13-30 as an "Interest Area" category designation:

and assign disclosure categories A and B to the Antelope Community Planning and Advisory Council.

- 4. Persons holding designated positions shall file statements of economic interest with the Clerk of the Board of Supervisors, the filing officer. The Clerk of the Board of Supervisors, or the designee of the Clerk, shall give timely notice of the filing requirements to the appointees and members of the Boards, Committees, Commissions and Councils.
- 5. This Conflict of Interest Code including Attachment 2 (Exhibit A and B) shall automatically include all Boards, Committees, Commissions, and Councils hereinafter created solely by this Board except as indicated by the resolution creating such Board, Committee, Commission or Council or amendment thereto.
- 6. In the event that coverage is not addressed in the resolution, all such Boards, Committees, Commissions or Councils shall automatically be covered by Attachment 1, Section 9, Category A of this Conflict of Interest Code; and
- 7. Any person may propose amendments to the disclosure requirements of this code regarding any County Board, Committee, Commission or Council. In order to initiate the appeal process the appointee must make a written request to the Clerk of the Board of Supervisors containing reasons for the proposed amendments. The Clerk of the Board of Supervisors shall notify the County Counsel of the proposed amendment and schedule the matter for public hearing. County Counsel shall make a recommendation regarding the proposed amendment at the public hearing at which time this Board shall issue its ruling.
 - 8. Sanctions for Failure to File Disclosure Statements:
- a) An appointee shall not assume office or exercise any of the rights, privileges or responsibilities of the office until the date on which the assuming office disclosure statement is filed. Failure of such an appointee to file the assuming office statement by the thirtieth (30th) day following the date of appointment shall, by operation of this rule, constitute a revocation of the appointment, and the office or position on the designated Board, Committee, Commission or Council shall be deemed vacant and subject to occupancy by a new appointment.
- b) Failure of a member of a Board, Committee, Commission or Council to file an annual statement of financial interest within thirty (30) days after the date on which the annual statement of financial interest is due shall, by operation of this rule, constitute a resignation, effective immediately, and the position on said Board, Committee, Commission or Council shall be deemed vacant and subject to occupancy by a new appointment.

- c) Upon removal from a Board, Commission, Committee, or Council for failing to file a Form 700, the member may reapply by completing the Form 700, completing the application and interview process, and being nominated by the Board of Supervisors for appointment to the Board, Commission, Committee, or Council.
- 9. Said Conflict of Interest Code shall become effective upon the date of adoption of this Resolution.

RESOLUTION TO AMEND THE COUNTY POLICY MANDATING ETHICS TRAINING FOR APPOINTED MEMBERS TO A BOARD, COMMISSION, COMMITTEE, OR COUNCIL PURSUANT TO ASSEMBLY BILL 1234 AND TO ESTABLISH A PROCESS FOR REAPPPOINTMENT

WHEREAS, on July 18, 2006 pursuant to the requirements of Assembly Bill (AB) 1234, the Board of Supervisors adopted Resolution 2006-0877 approving a policy to require ethics training for elected officials and specific County affiliated Boards, Commissions, Committees or Councils (BCCC); and

WHEREAS, on August 11, 2015, the Board of Supervisors adopted Resolution 2015-0617, to further ensure compliance with Government Code §53232 (et seq.), by amending this policy requiring ethics training per AB 1234 to include all appointed members to a BCCC designated to file a Statement of Economic Interests ("Form 700") among those individuals required to complete a minimum of two hours AB 1234 ethics training every two years; and

WHEREAS, Resolution 2015-0617 also stated that members who are appointed to a BCCC designated to file a Form 700 that fail to complete a minimum of two hours of AB 1234 ethics training every two years are subject to revocation of the appointment, and the office or position of the designated BCCC shall be deemed vacant and subject to occupancy by a new appointment; and

WHEREAS, a defined process is currently not in place for members who wish to reapply to a BCCC upon completing the requirements to file a Form 700 and complete ethics training; and

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that upon removal from a BCCC for failing to file a Form 700 or failing to complete the ethics training, a member may reapply by completing the Form 700 or ethics training, completing the application and interview process, and being nominated by the Board of Supervisors for appointment to the BCCC.

SECTION 1. ADOPTION OF CODE

The Political Reform Act (Government Code section 81000, et seq.) requires state and local government agencies to adopt and promulgate conflict of interest codes. The Fair Political Practices Commission has adopted a regulation (2 California Code of Regulations section 18730) which contains the terms of a standard conflict of interest code, which can be incorporated by reference in an agency's code. Therefore, the terms of 2 California Code of Regulations section 18730 and any amendments to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference. Regulation 18730 along with the information listed in this document and the attached Appendices (Exhibits) designating officials and employees and establishing disclosure categories, shall constitute the conflict of interest code of the County of Sacramento.

SECTION 2. LIST OF DESIGNATED POSITIONS AND DISCLOSURE CATEGORIES (EXHIBITS A AND B)

Each County board and commission subject to this Code (hereafter "Code Agency" or "Code Agencies") shall have an Exhibit A to this Code setting forth its designated positions required to file Statements of Economic Interests and setting forth the disclosure categories specifying the required disclosure interests (e.g., income, investments, business positions, real property) and the reportable sources of those interests.

SECTION 3. COUNTY BOARDS AND COMMISSIONS SUBJECT TO THIS CODE

Upon determination by the Office of County Counsel the following County board or commission is required to have a conflict of interest code with designated positions subject to Statement of Economic Interests disclosure, such board or commission shall be subject to this Code. Below is the list of each County board and commission with its own Exhibit A to this Code to specify its designated positions and disclosure categories.

Pursuant to Resolution No. 1990-1347, this Conflict of Interest Code including Exhibit A, shall automatically include all Boards, Committees, Commissions and Councils hereinafter created solely by the Board of Supervisors except as indicated by the resolution creating such Board, Committee, Commission or Council or amendment thereto.

Any person may propose amendments to the disclosure requirements of this code regarding any County Board, Committee, Commission or Council. In order to initiate the appeal process the appointee must make a written request to the Clerk of the Board of Supervisors containing reasons for the proposed amendments. The Clerk of the Board of Supervisors shall notify the Office of the County Counsel of the proposed amendment and schedule the matter for public hearing. County

Counsel shall make a recommendation regarding the proposed amendment at the public hearing at which time this Board shall issue its ruling.

SECTION 4. AMENDMENTS TO CODE AGENCIES' EXHIBITS A AND B

- (a) Every Code Agency shall amend its Exhibits "A" when change is necessitated by changed circumstances, including the creation of new positions which must be designated and relevant changes in the duties assigned to existing positions. Amendments or revisions shall be submitted to the Board of Supervisors by the Department of Personnel Services.
- (b) Notwithstanding subdivision (a), upon direction by the Board of Supervisors, each Code Agency shall review its Exhibits A in even-numbered years, upon notification by the Clerk of the Board. If no change in the Code Agency's Exhibit A is required, the head of the Code Agency shall submit a written statement to that effect to the Clerk of the Board no later than October 1 of the same year. If a change in the Code Agency's Exhibit A is necessitated by changed circumstances, the Code Agency shall submit an amended Exhibit A through the Clerk of the Board to the Board of Supervisors.

SECTION 5. FILING OFFICIALS

Each Code Agency shall have at least one designated Filing Official. The Filing Official is responsible for, among other things: (1) forwarding the Statements of Economic Interests from the Code Agency's filers to the Clerk of the Board or ensuring the filers' Statements are e-filed in the County's electronic system; (2) supplying the necessary forms and manuals prescribed by the Fair Political Practices Commission to the Code Agency's filers; (3) notifying the Clerk of the Board regarding new individuals in designated positions, individuals leaving designated positions, and other events affecting filing obligations; and (4) notifying the Clerk of the Board no later than February 1 of each year of the names and positions of every person whose Statements of Economic Interests must be forwarded to the Clerk of the Board.

SECTION 6. FILING REQUIREMENTS

Each individual holding a position designated in this Code, other than those officials who file pursuant to Government Code section 87200 (identified in Exhibit C to this Code), shall file Statements of Economic Interests disclosing the information required by the position's assigned disclosure category as set forth in this Code, on such forms as may be specified by the Fair Political Practices Commission (Form 700 unless otherwise provided by the Commission), and at such times required by Regulation 18730. Every individual holding a position designated in this Code shall retain his or her filing obligations, notwithstanding any reclassification or title change that may occur in the future as to the same job duties.

Statements of Economic Interests may be filed via paper submission or electronically using the County's electronic Form 700 system known as eDisclosure. Filers shall submit paper-submitted Statements of Economic Interests to the Filing Official of their Code Agency. If Statements of Economic Interests are e-filed in eDisclosure, both the Code Agency Filing Official and the County Clerk of the Board's Office receive notice and access to the e-filed Statements simultaneously.

SECTION 7. FAILURE TO FILE

Failure to file Statements of Economic Interests on time may result in penalties imposed by state law, including, but not limited to, monetary fines. Members of County boards and commissions who fail to file Statements of Economic Interests may be subject to removal by the Board of Supervisors.

SECTION 8. FILING OFFICER

With the exception of those officials who file pursuant to Government Code section 87200 (identified in Exhibit C to this Code), the Clerk of the Board shall be the Filing Officer. Statements of Economic Interests submitted to the Clerk of the Board by designated employees in accordance with this Code shall be available for public inspection and reproduction pursuant to Government Code section 81008.

SECTION 9. DISCLOSURE CATEGORIES

For each Code Agency, disclosure categories shall include Categories A through F as specified in Section 9, and such additional categories as determined by each Code Agency and included in each Code Agency's Exhibit A and B attached to and incorporated into this Code.

SECTION 9. DISCLOSURE CATEGORIES A THROUGH F

<u>Disclosure Category A</u>: Persons designated in this category are members of a BCCC appointed by the Board of Supervisors that have been designated to disclose:

- (1) all investments, business entities, and income from:
 - (a) all sources that provide, plan to provide, or have provided in the last two years, facilities, goods, software, hardware, or related technology, equipment, vehicles, machinery or services, construction or engineering services, publishing, printing, reproduction services or selling newspapers including training or consulting services;
 - (b) all sources that are subject to the regulatory, monitoring, investigatory, enforcement, valuation, certification, permit or licensing authority of the County, or have an application for a license, permit or certificate pending before the County;
 - (c) all sources that receive, are planning to apply to receive, or have received in the last two years, grants or other monies from or through the County.

Designated persons in this category shall complete Schedules A-1 and A-2 of Form 700, if applicable. See FPPC Schedules A-1 and A-2 for additional information.

<u>Disclosure Category B</u>: Persons designated in this category are members of a BCCC appointed by the Board of Supervisors that have been designated to disclose:

- (1) all interest in real property in the County of Sacramento located entirely or partly within the County, or within two miles of County boundaries, or of any land owned or used by the County (except personal residence occupied by you or your family, if used exclusively as a personal residence) This could include:
 - (a) any leasehold beneficial or ownership interest or portion to acquire such interest in real property, if the fair market value of the interest is two thousand dollars (\$2,000) or more.
 - (b) all sources that involve real estate sales or rental or services associated with the conveyance of real property.

Designated persons in this category shall complete Schedule B of Form 700, if applicable. See FPPC Schedule B for additional information.

<u>Disclosure Category C</u>: Persons designated in this category are members of a BCCC appointed by the Board of Supervisors that have been designated to disclose:

- (1) all income, loans, and business positions from:
 - (a) all sources that provide, plan to provide, or have provided in the last two years, facilities, goods, software, hardware, or related technology, equipment, vehicles, machinery or services, construction or engineering services, publishing, printing, reproduction services or selling newspapers including training or consulting services;
 - (b) all sources that are subject to the regulatory, monitoring, investigatory, enforcement, valuation, certification, permit or licensing authority of the County, or have an application for a license, permit or certificate pending before the County;
 - (c) all sources that receive, are planning to apply to receive, or have received in the last two years, grants or other monies from or through the County.

Designated employees in this category shall complete Schedule C of Form 700, if applicable. See FPPC Schedule C for additional information.

Disclosure Category D: Persons designated in this category are members of a BCCC appointed by the Board of Supervisors that have been designated to disclose all income from gifts. Designated persons in this category shall complete Schedule D of Form 700, if applicable. See FPPC Schedule E for additional information.

<u>Disclosure Category E</u>: Persons designated in this category are members of a BCCC appointed by the Board of Supervisors that have been designated to disclose all travel payments, advances, and reimbursements for travel related expenses including lodging and meals. Designated

persons in this category shall complete Schedule E of Form 700, if applicable. See FPPC Schedule E for additional information.

Disclosure Category F: Persons designated in this category are members of a BCCC appointed by the Board of Supervisors and are consultants and/or contractors that provide services to the County of Sacramento and shall disclose:

- (1) All investments, business positions and income, including gifts, loans and travel payments, from sources that provide leased facilities, goods, equipment, vehicles, machinery or services, including training or consulting services, of the type utilized by the County.
- (2) all interests in real property in the County of Sacramento located entirely or partly within the County, or within two miles of county boundaries, or of any land owned or used by the County (except personal residence occupied by you or your family, if used exclusively as a personal residence), subject to the following limitation: the County may determine in writing, following approval by County Counsel as to form and legality, that the particular consultant is hired to perform a range of duties that is limited in scope and, thus, is not required to comply with the full disclosure requirements described above, but instead must comply with more tailored disclosure requirements specific to that consultant/contractor. Such a determination shall include a description of the consultant's/contractor's duties and, based upon that description, a statement of the extent of disclosure requirements.

Designated persons in this category shall complete all FPPC schedules of Form 700, if applicable.

SECTION 10. INTERIM DISCLOSURE REQUIRED FOR NEWLY CREATED POSITIONS PENDING CODE AMENDMENT

- (a) Persons in newly created positions that make or participate in the making of decisions that may foreseeably have a material effect on any financial interest and are not yet listed in this Code, shall file interim disclosure.
- (b) As soon as any Code Agency determines that it has a newly created position that must file Statements of Economic Interests, the Code Agency Filing Official shall contact the Clerk of the Board for review of the appropriate disclosure requirements. The Clerk of the Board shall work with the Office of the County Counsel and the Code Agency to determine the appropriate interim disclosure and update the Code Agency's Exhibit.
- (c) Persons in positions specified in subdivision (a) of this Section shall file under Category A, the broadest disclosure category, in this Code until the Code Agency amends its Exhibit to reflect the Code Agency/position and its specified disclosure category. However, prior to the Exhibit amendment, the Code Agency for which the position works may determine in writing, following approval by County Counsel, that the position performs a range of duties that are limited in scope

and, thus, is not required to comply with the disclosure requirements of Category A, but must comply with more tailored disclosure requirements specific to that position. Such a determination shall include a description of the position's duties and, based upon that description, a statement of the extent of disclosure requirements.

(d) A written determination under this Section shall be a public record and shall be retained for public inspection in the Clerk of the Board's Office.

BOARDS, COMMITTEES, COMMISSIONS & COUNCILS

SECTION 1. ADOPTION OF CODE

The Political Reform Act (Government Code section 81000, et seq.) requires state and local government agencies to adopt and promulgate conflict of interest codes. The Fair Political Practices Commission has adopted a regulation (2 California Code of Regulations section 18730) which contains the terms of a standard conflict of interest code, which can be incorporated by reference in an agency's code. Therefore, the terms of 2 California Code of Regulations section 18730 and any amendments to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference. Regulation 18730 along with the information listed in this document and the attached Appendices (Exhibits) designating officials and employees and establishing disclosure categories, shall constitute the conflict of interest code of the County of Sacramento.

SECTION 2. LIST OF DESIGNATED POSITIONS AND DISCLOSURE CATEGORIES (EXHIBITS A AND B)

Each County board and commission subject to this Code (hereafter "Code Agency" or "Code Agencies") shall have an Exhibit A to this Code setting forth its designated positions required to file Statements of Economic Interests and setting forth the disclosure categories specifying the required disclosure interests (e.g., income, investments, business positions, real property) and the reportable sources of those interests.

SECTION 3. COUNTY BOARDS AND COMMISSIONS SUBJECT TO THIS CODE

Upon determination by the Office of County Counsel the following County board or commission is required to have a conflict of interest code with designated positions subject to Statement of Economic Interests disclosure, such board or commission shall be subject to this Code. Below is the list of each County board and commission with its own Exhibit A to this Code to specify its designated positions and disclosure categories.

Pursuant to Resolution No. 1990-1347, this Conflict of Interest Code including Exhibit A, shall automatically include all Boards, Committees, Commissions and Councils hereinafter created solely

by the Board of Supervisors except as indicated by the resolution creating such Board, Committee, Commission or Council or amendment thereto.

Any person may propose amendments to the disclosure requirements of this code regarding any County Board, Committee, Commission or Council. In order to initiate the appeal process the appointee must make a written request to the Clerk of the Board of Supervisors containing reasons for the proposed amendments. The Clerk of the Board of Supervisors shall notify the Office of the County Counsel of the proposed amendment and schedule the matter for public hearing. County Counsel shall make a recommendation regarding the proposed amendment at the public hearing at which time this Board shall issue its ruling.

SECTION 4. AMENDMENTS TO CODE AGENCIES' EXHIBITS A AND B

- (a) Every Code Agency shall amend its Exhibits "A" when change is necessitated by changed circumstances, including the creation of new positions which must be designated and relevant changes in the duties assigned to existing positions. Amendments or revisions shall be submitted to the Board of Supervisors by the Department of Personnel Services.
- (b) Notwithstanding subdivision (a), upon direction by the Board of Supervisors, each Code Agency shall review its Exhibits A in even-numbered years, upon notification by the Clerk of the Board. If no change in the Code Agency's Exhibit A is required, the head of the Code Agency shall submit a written statement to that effect to the Clerk of the Board no later than October 1 of the same year. If a change in the Code Agency's Exhibit A is necessitated by changed circumstances, the Code Agency shall submit an amended Exhibit A through the Clerk of the Board to the Board of Supervisors.

SECTION 5. FILING OFFICIALS

Each Code Agency shall have at least one designated Filing Official. The Filing Official is responsible for, among other things: (1) forwarding the Statements of Economic Interests from the Code Agency's filers to the Clerk of the Board or ensuring the filers' Statements are e-filed in the County's electronic system; (2) supplying the necessary forms and manuals prescribed by the Fair Political Practices Commission to the Code Agency's filers; (3) notifying the Clerk of the Board regarding new individuals in designated positions, individuals leaving designated positions, and other events affecting filing obligations; and (4) notifying the Clerk of the Board no later than February 1 of each year of the names and positions of every person whose Statements of Economic Interests must be forwarded to the Clerk of the Board.

SECTION 6. FILING REQUIREMENTS

Each individual holding a position designated in this Code, other than those officials who file pursuant to Government Code section 87200 (identified in Exhibit C to this Code), shall file Statements of Economic Interests disclosing the information required by the position's assigned disclosure category as set forth in this Code, on such forms as may be specified by the Fair Political Practices Commission (Form 700 unless otherwise provided by the Commission), and at such times required by Regulation 18730. Every individual holding a position designated in this Code shall retain his or her filing obligations, notwithstanding any reclassification or title change that may occur in the future as to the same job duties.

Statements of Economic Interests may be filed via paper submission or electronically using the County's electronic Form 700 system known as eDisclosure. Filers shall submit paper-submitted Statements of Economic Interests to the Filing Official of their Code Agency. If Statements of Economic Interests are e-filed in eDisclosure, both the Code Agency Filing Official and the County Clerk of the Board's Office receive notice and access to the e-filed Statements simultaneously.

SECTION 7. FAILURE TO FILE

Failure to file Statements of Economic Interests on time may result in penalties imposed by state law, including, but not limited to, monetary fines. Members of County boards and commissions who fail to file Statements of Economic Interests may be subject to removal by the Board of Supervisors.

SECTION 8. FILING OFFICER

With the exception of those officials who file pursuant to Government Code section 87200 (identified in Exhibit C to this Code), the Clerk of the Board shall be the Filing Officer. Statements of Economic Interests submitted to the Clerk of the Board by designated employees in accordance with this Code shall be available for public inspection and reproduction pursuant to Government Code section 81008.

SECTION 9. DISCLOSURE CATEGORIES

For each Code Agency, disclosure categories shall include Categories A through F as specified in Section 9, and such additional categories as determined by each Code Agency and included in each Code Agency's Exhibit A and B attached to and incorporated into this Code.

SECTION 9. DISCLOSURE CATEGORIES A THROUGH F

<u>Disclosure Category A</u>: Persons designated in this category are members of a BCCC appointed by the Board of Supervisors that have been designated to disclose:

- (1) all investments, business entities, and income from:
 - (a) all sources that provide, plan to provide, or have provided in the last two years, facilities, goods, software, hardware, or related technology, equipment, vehicles, machinery or services, construction or engineering services, publishing, printing, reproduction services or selling newspapers including training or consulting services;
 - (b) all sources that are subject to the regulatory, monitoring, investigatory, enforcement, valuation, certification, permit or licensing authority of the County, or have an application for a license, permit or certificate pending before the County;
 - (c) all sources that receive, are planning to apply to receive, or have received in the last two years, grants or other monies from or through the County.

Designated persons in this category shall complete Schedules A-1 and A-2 of Form 700, if applicable. See FPPC Schedules A-1 and A-2 for additional information.

Disclosure Category B: Persons designated in this category are members of a BCCC appointed by the Board of Supervisors that have been designated to disclose:

- (1) all interest in real property in the County of Sacramento located entirely or partly within the County, or within two miles of County boundaries, or of any land owned or used by the County (except personal residence occupied by you or your family, if used exclusively as a personal residence) This could include:
 - (a) any leasehold beneficial or ownership interest or portion to acquire such interest in real property, if the fair market value of the interest is two thousand dollars (\$2,000) or more.
 - (b) all sources that involve real estate sales or rental or services associated with the conveyance of real property.

Designated persons in this category shall complete Schedule B of Form 700, if applicable. See FPPC Schedule B for additional information.

<u>Disclosure Category C</u>: Persons designated in this category are members of a BCCC appointed by the Board of Supervisors that have been designated to disclose:

- (1) all income, loans, and business positions from:
 - (a) all sources that provide, plan to provide, or have provided in the last two years, facilities, goods, software, hardware, or related technology, equipment, vehicles, machinery or services, construction or engineering services, publishing, printing, reproduction services or selling newspapers including training or consulting services;
 - (b) all sources that are subject to the regulatory, monitoring, investigatory, enforcement, valuation, certification, permit or licensing authority of the County, or have an application for a license, permit or certificate pending before the County;
 - (c) all sources that receive, are planning to apply to receive, or have received in the last two years, grants or other monies from or through the County.

Designated employees in this category shall complete Schedule C of Form 700, if applicable. See FPPC Schedule C for additional information.

Disclosure Category D: Persons designated in this category are members of a BCCC appointed by the Board of Supervisors that have been designated to disclose all income from gifts.

Designated persons in this category shall complete Schedule D of Form 700, if applicable. See FPPC Schedule E for additional information.

Disclosure Category E: Persons designated in this category are members of a BCCC appointed by the Board of Supervisors that have been designated to disclose all travel payments, advances, and reimbursements for travel related expenses including lodging and meals. Designated persons in this category shall complete Schedule E of Form 700, if applicable. See FPPC Schedule E for additional information.

Disclosure Category F: Persons designated in this category are members of a BCCC appointed by the Board of Supervisors and are consultants and/or contractors that provide services to the County of Sacramento and shall disclose:

- (1) All investments, business positions and income, including gifts, loans and travel payments, from sources that provide leased facilities, goods, equipment, vehicles, machinery or services, including training or consulting services, of the type utilized by the County.
- (2) all interests in real property in the County of Sacramento located entirely or partly within the County, or within two miles of county boundaries, or of any land owned or used by the County (except personal residence occupied by you or your family, if used exclusively as a personal residence), subject to the following limitation: the County may determine in writing, following approval by County Counsel as to form and legality, that the particular consultant is hired to perform a range of duties that is limited in scope and, thus, is not required to comply with the full disclosure requirements described above, but instead must comply with more tailored disclosure requirements specific to that consultant/contractor. Such a determination shall include a description of the consultant's/contractor's duties and, based upon that description, a statement of the extent of disclosure requirements.

Designated persons in this category shall complete all FPPC schedules of Form 700, if applicable.

SECTION 10. INTERIM DISCLOSURE REQUIRED FOR NEWLY CREATED POSITIONS PENDING CODE AMENDMENT

- (a) Persons in newly created positions that make or participate in the making of decisions that may foreseeably have a material effect on any financial interest and are not yet listed in this Code, shall file interim disclosure.
- (b) As soon as any Code Agency determines that it has a newly created position that must file Statements of Economic Interests, the Code Agency Filing Official shall contact the Clerk of the Board for review of the appropriate disclosure requirements. The Clerk of the Board shall work with

the Office of the County Counsel and the Code Agency to determine the appropriate interim disclosure and update the Code Agency's Exhibit.

- (c) Persons in positions specified in subdivision (a) of this Section shall file under Category A, the broadest disclosure category, in this Code until the Code Agency amends its Exhibit to reflect the Code Agency/position and its specified disclosure category. However, prior to the Exhibit amendment, the Code Agency for which the position works may determine in writing, following approval by County Counsel, that the position performs a range of duties that are limited in scope and, thus, is not required to comply with the disclosure requirements of Category A, but must comply with more tailored disclosure requirements specific to that position. Such a determination shall include a description of the position's duties and, based upon that description, a statement of the extent of disclosure requirements.
- (d) A written determination under this Section shall be a public record and shall be retained for public inspection in the Clerk of the Board's Office.
