Dear CPAC board,

I'm writing in response to your upcoming meeting where you will discuss the permit for Nature's Lab School in their new location (PLNP2019-00366 - Sac Metro Preschool Use Permit Amendment).

My husband and I are both Olympic medalists (Gold medal in volleyball for him, Bronze medal in synchronized swimming for me) and as a result we have both traveled the world and thought extensively how we can work to expand the experiences of our children so they can grow and learn and benefit, like we have benefitted, from our experiences.

We were so happy to find Nature's Lab and our son (now 3 years old) was one of the first few students to join the school. The original interest was the bilingual education which was important to us as we both speak multiple languages. But our love for the school, and our appreciation for the experiences our children have while at school have grown so much over the last 2 years. (Now our 20 month old daughter attends as well).

Nature's Lab has provided resources on a discipline method called "Conscious discipline". It's been a tremendous support when we are working hard to create good little citizens who are consciousness, kind, gentle, fair, loving and joyful. Nature's Lab has provided resources and support for good sleep habits so that the kiddos are more even tempered, and better equipped to learn and connect with other students. My kids are exposed to a wide range of foods, and foods that come directly from the NatLab garden. They love to eat plums, blackberries and bell peppers and tomatoes right off the bushes/trees! They feel connected to food, and learn about how it nourishes their little bodies so they can grow "big and strong" as my son says. They learn to take care of animals and I've seen my children have such a capacity to be gentle and loving to the animals at school, and our animals at home. (Admittedly, I do have to remind them that our dog is not a horse.....but besides that lots of love and respect for our pets!)

One of my issues with other schools we visited was the lack of outdoor time for the kids. It was maybe 2-3 hours a day and always very structured. explore and learn on their own as well. I see how much joy this brings them.

The staff at NatLab is amazing. They are caring, and communicative. My kids call their teachers "my best friends". It's so important to me that my children know that they have a community of adults that love them, cherish them, nurture them, protect them and care for them. I know this buoys their self confidence, and their world view. The staff makes a concerted effort to inform me of challenges or accomplishments. And they are always open to feedback when I'm working to build on a skill for my kids.

An expanded Nature's Lab in their new location would be so wonderful, so that more children and families can experience the strong supportive community that Silvia Anderson has developed, fostered, and continues to improve. These first few years of our children's lives will leave an indelible mark on them, and set them up for a hearthealthy, successful future.

The proposed amendment, as I understand it, is so that the location at issue can be utilized by Nature's Lab School. I am a mother of a two-year-old little girl who currently attends Nature's Lab School at its existing location, has been in full-time attendance since soon after the school opened, and I am also a Carmichael resident. I am writing in support of the modification and proposed new location for Nature's Lab School.

I feel very strongly about how much of an asset this school is not just to my family but to our community. I was lucky enough to get a spot at Nature's Lab School, and I am so grateful, not only because there were very limited options as to childcare at the time, but also because I was very picky about the type and quality of care for my daughter and did not want to send her just anywhere. Silvia and the other teachers at the school are the most excellent care I could ever have hoped for, far exceeding my expectations. They legitimately care about my daughter as if she was part of their family. Also, the outdoor education model aligns with my personal education values and has proven extremely enriching for my child. Nature's Lab School provides various options as to schedule, so it caters to a diverse group of parents, both those that work full time and those that only need childcare on a part-time basis.

The Nature's Lab teachers are not just care providers. They communicate with me about my child and her needs outside of school hours. They conduct workshops related to child development and parenting. They have regular parent-teacher conferences. They offer resources they believe may be useful to parents. They seek input from parents when making certain decisions about how they operate. They go above and beyond just watching my child during certain hours. They legitimately and deeply care about my child's development. And I think that is THE most important thing childcare needs to be offering to families.

Regarding outdoor education, I knew from the beginning when I started searching for a school that my child spending time outside was one of the most important things I was looking for. Plenty of schools I toured either spent the majority of their time inside or didn't even have a suitable or stimulating outdoor area. I feel like Giana is so much more intellectually and emotionally stimulated now, because she gets to spend so much time playing outdoors. And it is not just any outdoor space. In addition to climbing structures there is a sandbook, a stage with musical instruments, a mud kitchen, etc. There are also animals, which I believe research consistently shows are important for children to build empathy and other social/emotional skills. There is literally no other program in the entirety of the Sacramento area, that I am aware of, that offers these kinds of services or facilities to families.

In addition, I feel it is important that caregivers are educated and informed regarding child development and theory. Silvia of course has impressive accolades, but all of the teachers are very skilled. Childcare, I believe, is something that necessarily should go above and beyond just watching kids. Children of young age are in their most formative years, and I feel strongly caregivers should be consciously using methods that are designed to enrich children intellectually and emotionally, and Nature's Lab definitely excels in this regard.

I cannot say enough positive things about Nature's Lab School. When childcare is generally so difficult to secure, not to mention high quality childcare, to say Nature's Lab has been an asset to our family is an understatement. I think other Carmichael residents in the surrounding location will agree.

I am writing this letter in support of my toddler daughter's daycare facility, Nature's Lab Playschool, currently located in a home-based environment in Carmichael. Nature's Lab Playschool is looking to move to a larger facility nearby for a number of reasons, among those to accommodate the many families awaiting a high-quality childcare spot in a region with abysmal availability for child care in the first place. According to 2017 figures from childdata.org, only 28.2% of children whose parents are part of the labor force can be accommodated through existing childcare options; this statistic likely looks more grim in a post-Covid world after many (roughly 10%) of child care-providing facilities in California have closed. With these bleak figures, there's hardly any bandwidth left on conversations about quality.

Despite the terrible odds of securing child care in Sac County, our family was tremendously fortunate to find Nature's Lab Playschool in December 2018, shortly after owner Silvia Anderson opened her facility. Our daughter was close to a year old and we had cobbled together childcare by taking leaves from our respective professions, scaling back on our workload (and income) and flying relatives in from other states on a monthly basis as a stopgap measure. Our daughter immediately took to the mostly outdoor, play-based environment at Nature's Lab and immediately bonded with the staff. While we did not have a choice of daycare facility per se (since no other options were available for children under 2 to us at the time), had we had a choice, we would have still chosen Nature's Lab Playschool. The things that set Nature's Lab apart from the other many many facilities that we toured (but had no availability for years to come) include:

• Children are encouraged to engage in self-directed play with natural, open-ended materials outside, rain or shine. This supports our own parenting philosophies and is in line with the evidence base for child development. Children with access to outdoor play-based activities are less likely to be obese, have

stronger immune systems, are less likely to contract communicable illnesses, and exhibit higher levels of attention and well-being. (Bento & Dias, 2017 in The importance of outdoor play for young children's healthy development) To quote Erin K. Kennt, author of the book Forest Kindergartens, "Children cannot bounce off the walls if we take away the walls."

- Children are encouraged to be stewards of their environment and for the animals in their care. Through this, they are learning how to be gentle with vulnerable critters (from stick insects and butterflies to bunnies) and are slowly taking on more care-taking responsibilities. Through this exposure to natural organisms, our daughter is endlessly curious (instead of afraid) about all the various creatures she finds in our backyard.
- Similarly, children are expected to be good stewards of their playthings and school environment. This has translated wonderfully to our home environment, where our barely two-year-old daughter clears her own plate and loads it in the dishwasher after meals, helps prepare the meals, sets the table, sorts clean laundry, puts her clothes in the laundry basket, tidies up her toys after she is done playing with them, and cleans up any spills and drips if furnished with the appropriate tools. While she is strong-willed and fussy about a great many things, she does these tasks willingly at home because they are an extension of some of the expectations Nature's Lab has for their kiddos.
- Nature's Lab Playschool has a Spanish-immersion component that I find invaluable. The children engage with the caretakers in Spanish roughly 60% of the time. I have witnessed my daughter receiving complex instructions in Spanish from Nature's Lab staff and respond accordingly. While I do not expect my daughter to grow up fully bilingual, having exposure to a second language during the critical language learning period allows children to intuitively understand that languages vary systematically; this will facilitate greater ease of language learning for her in the future. As a multicultural, multiracial, and multilinguistic family, this was a high priority for us and one we feel very lucky to have found in Nature's Lab.
- The staff is absolutely fantastic. Our daughter has bonded with every child care provider at Nature's Lab and speaks of them fondly at home. In a place where we have no extended family, they dually fill the role of aunt, cousin, etc and provide an alternative adult role model, one that is likely more positive than stressed-out working from home parents. : )
