RE: Arden Arcade Community Planning Advisory Council meeting of 05/28/2020, Agenda Item 1, PLNP2020-00002 Circle D Food Store PCN

I strenuously oppose the subject applicant's PCN request. There are far too many off-sale liquor licenses in Arden Arcade. Data from the California Alcoholic Beverage Commission (ABC) show that Arden Arcade has 1/2 of the off-sale licenses issued by the County for the unincorporated area, yet the community has but 1/6 of the unincorporated area's population. Arden Arcade is awash with off-sale liquor licenses. It is not an off-sale beer, wine or hard liquor desert. It is burdened with a vastly disproportionate share of the off-sale liquor licenses permitted by the County

From my experience with prior PCN applications in recent years, it has been made abundantly clear that:

- the Census Tracts in Arden Arcade have an oversupply of off-sale licenses
- the Sheriff considers every such location to have crime problems
- enforcement of alcohol laws and regulations is inadequate to the point that the ABC and the Sheriff's office have urged citizen assistance
- conditions placed on sellers are easily and routinely violated without an significant consequence and are often relaxed as time goes by
- the ABC and the ABC Appeals Board consider local PCN decisions final

Having been in business in the same ownership for over two decades, it is not clear that the Circle D Food Store store should now become a beer-and-wine store. Further, this particular license application is problematic for several reasons:

- TOO MANY ALREADY the store's specific Census Tract has 6 off-sale licenses, there are 11 other off-sale sites are literally across the street from the Tract, and the abundance of those sites clearly works against both public convenience and necessity (ABC data)
- NOT NEEDED the Tract has 5070 residents, which translates to a need for less than 3 off-sale licenses per ABC criteria (US Census data)
- POVERTY the Tract has 32% residents below 150% of the poverty level and 5% primarily in the immediate area near the store living on public assistance (US Census data)
- TRANSIENCY the Tract's housing units are 62% renter-occupied, 30% non-family and 5% overcrowded, with particular impact in the immediate vicinity of the store (US Census data)
- UNFAIR/EXPLOITIVE The Tract's poverty and low-cost apartments have resulted in a concentration of underprivileged people (12% residents unemployed pre-pandemic vs 4-5% elsewhere, 13% residents 25 y.o. or older lack even a high school diploma) who

- are largely people of color (34%) and/or recent immigrants (18% do not speak English well, 27% foreign-born). (US Census data)
- POLICY CONFLICT The Tract is located within the County-designated West Arden Environmental Justice area, the plans for which speak to the need to prevent crime, reduce pollution exposure, ensure safe and sanitary housing, provide access to public facilities and food, and promote physical activity and civic engagement. (https://planning.saccounty.net/PlansandProjectsIn-Progress/Pages/Environmental-Justice-Element.aspx)

The community doesn't need or want another off-sale liquor license. There is already a plethora of convenient, nearby sites for purchase of off-sale beer and wine. The immediate neighborhood - impacted as it is by crime, homeless encampments, and unabated piles of trash and junk - doesn't want or deserve the existing food store to be yet another off-sale liquor license location. The County has already recognized the need to address and solve the myriad problems associated with an area that already suffers from crime, neglect and deterioration.

In the past the CPAC has turned down some PCN applications, standing with the community against worsening the existing overabundance of off-sale liquor licenses. Please do so again.
