I am a resident of Carmichael, California and live on Horton Lane off of Sutter Avenue and highly object to this request.

I have complained for years now about the excessive traffic on our street, other residents in my area have also complained about the heavy traffic on our street. Our street has become a very dangerous street due to the excessive traffic coming from Fair Oaks Blvd., Sutter Avenue and Gibbons Drive. There have been numerous crimes on our street, our cars are broken into, theft, I have witness drug dealings, transients. A police stand off, family pets have been killed by random drivers who drive at excessive speeds down our street. There have been several car accidents. I can not even back out of my driveway without fear because cars speed down the street without consideration of other drivers.

I could stand outside for ten minutes and witness 5-7 cars speeding down our street and failing to stop at either stop sign (The one on Gibbons and the one on Sutter). Our cars have been broken into on at least 3 occasions. Almost everyone on our street has experience some kind of theft, there are strangers walking down our streets checking to see if our cars are open or if garage doors are open so I have had to invest in alarm systems on my home, vehicle and cameras on my property to protect my family. I also had to build a fence around my yard so that strangers would stay off my property. I have had to ask several people to not pull in my driveway to turn their vehicles around. I have witnessed on so many occasions, strangers walking on my neighbors property to check look in cars, windows and looking over back fences. We can not safely walk on our street or feel safe in our homes because of this crime. I fear for my young child and the other children on the street. As a lifelong Carmichael resident, I am expressing my opposition to the proposed new gas station and liquor store at FO Blvd and Sutter Ave.

Less than 1/4 mile East on Sutter Ave is Carmichael Elementary School. Authorizing a 24 liquor store/gas station at this location will possibly expose young children to alcohol users and certainly added criteria pollutants from increased vehicle traffic.

Within approximately 1 mile both north and south from this proposed location there are existing 24 hour gas stations/liquor stores.

As a longtime Carmichael resident (30 years this summer) I am writing to **OPPOSE** the approval for a 24 hour 7-Eleven gas station, convenience store with liquor sales proposed for the northeast corner of Sutter and Fair Oaks Blvd. My reasons are as follows:

- 1) There are already 2 gas stations (Arco and Safeway) within 1/3 mile of the proposed site (with one on each side of Fair Oaks Blvd.). History has shown that gas stations have the potential to pollute the ground, aquifers and air. We do not need to add to the possibility of more exposure to these contaminants when other existing businesses are already accessible to the public.
- 2) There are already 2 groceries stores (Bel Air and Safeway) within a 1/4 mile of the proposed site (with one on each side of Fair Oaks Blvd.) But for the current Covid19 SIP orders, both these businesses have extended hours that meet the needs of Carmichael residents to purchase food, and other essential and non-essential items (including cigarettes and liquor).
- 3) The corridor between Marconi Ave. Fair Oaks split and Manzanita Ave. is already one of the most congested roads in Carmichael. Dear Community Planning Advisory Council

As a property owner and a business owner that owns and occupies commercial space adjacent to the proposed 7-11 convenience store and gas station, I am voicing my strong opposition to the proposed project for a variety of reasons detailed herewith:

- 1). Liquor sales at this corner parcel is an unwanted addition to a neighborhood plagued with homelessness and public intoxication. Here in Carmichael, we have an unyielding issue with homeless encampments and the trash, human feces, needles, smashed bottles, graffiti, and difficult personalities terrorizing and shocking my employees with scenes you could not believe if you hadn't seen it for yourself on our security cameras.
- 2). A sober living men's residence is located immediately adjacent to the parcel that will aggravate and further make more complicated the painstaking process of daily sobriety and responsibility. As a neighborhood business to this men's residential facility, we have spent many years establishing a relationship founded on mutual respect. At times it doesn't work, such as the time we found the residents and homeless visitors congregating and sharing drugs and alcohol on our premises. The management of this home was quick to resolve the situation and return their residents to their treatment course. More liquor a mere pajama walk away to the next door 7 11 will negatively affect all the progress we have made.
- 2). The Sacramento County sheriff is inundated with service calls dealing with intoxicated trespassers, and response to times have increased significantly if not altogether vanished over the years I have been here. With the advent of the Carmichael Business Improvement District, we have a fighting chance to take back the community and structure new development in line with main street vision we have spent so many years and millions of dollars developing, primarily with the idea towards building more pedestrian friendly commercial storefronts and inviting sidewalks. A multitude of driveway ramps, gas pumps, cheap unhealthy snack foods, and highly caffeinated beverages, do not serve that purpose.

- 3). There is alcohol and cigarettes available across two streets in every direction. This is not an underserved part of Carmichael when it comes to package liquor, wine, beer and cigarette sales. It is EVERYWHERE already! The trash left behind on the streets and sidewalks are all the evidence you need to see what happens when liquor and cigarette sales take over a neighborhood.
- 4). My business immediately next door to this 7 11 project is a 1700 square foot, 24 hour emergency call center for medical spoken language interpreting services. We support emergency rooms, clinics and outpatient therapeutics 24/7/365 in medical and social service venues coast-to-coast. With the unending homeless encampments, we fight with every morning and late night, more liquor sales next door will be a disaster. I am continually concerned for the safety of my 20+ employees who work late night and early morning shifts in a very stressful job, that requires them to get out of their chair and decompress by walking outside. They are met with urine smell, human defecation, used hypodermic needles, broken bottles, dangerous loiterers and other detritus left behind by alcohol and drug infected visitors.
- 5). The ingress to this property on Sutter Avenue will create a safety hazard for young pedestrians as cars interested in dodging the red light on Sutter Ave will shortcut their turn onto Fair Oaks Blvd. by cutting through the service station. As you know, 6141 Sutter Avenue is the address for Carmichael Elementary School. School children walk past these driveways by the dozens every morning and afternoon for their roundtrip to school and back. Concern for these young pedestrians should be primary when planning and developing this important corner and its concomitant path of travel walkway for grade school children.
- 6). From a health equity standpoint, convenience store food items are not healthy food and drink alternatives to a low-income community struggling with food insecurity. We need more fresh fruit and less candy and hi caloric beverages empty of nutritional value.
- 7). A gas station is environmentally a terrible use for our main street, and like liquor, beer and wine, there is no scarcity of gas stations in this neighborhood. In fact, we have several high volume gas stations/convenience stores located nearby at the Safeway shopping center and the ARCO located at Cypress and Manzanita.

Thank you for your inclusion of these comments, and I look forward to hearing how the Advisory Council provides the community with next steps.

I wanted to speak out in opposition to the proposed establishment of a 24 hour 7/11 gas and convenience store which would sell alcohol at 7300 Fair Oaks Blvd. This is in such stark contrast to what our Carmichael Community needs at this point in time.

We really don't need another gas station, convenience store or alcohol sales in our community, especially at this intersection. In addition to other such services (gas, convenience, alcohol) in our community, the two AM/PM gas/convenience stores at Manzanita and Cypress and Fair Oaks and Marconi are extremely troubling in that they have become centers for homeless, mentally impaired and drug dealing people. Until we figure out how to deal with these problems relative to these facilities...I suggest that we beg off for the time being.

In addition to the lack of need for these facilities...it also represents an increase in harm. We have many children that frequent this neighborhood, we have a school a half block away, an adult halfway house/recovery center merely yards away, we have increased traffic which would be exacerbated by this facility.

This is a no win situation for our community. Please reject this proposal.
