To the Members of the Carmichael-Old Foothill Farms Community Planning Advisory Council

I am writing in strong opposition to approval in any form of the Items 2 and 3 (PLNP2019-00261 and PLNP2019-00262) on the May 20, 2020 CPAC agenda.

I have been a resident of Carmichael since 1979. During this period of time I have been very active in volunteering and supporting my Community, serving on the Carmichael Park Board, and the Carmichael Colony Neighborhood Association. In addition, I served as Chairman of the Carmichael Community Action Plan (CCAP) effort and also on the Carmichael Planning Council during preparation of the Fair Oaks Blvd. Corridor Plan.

Those efforts resulted in these current active planning documents and subsequent zoning regulations for Carmichael. The preparation of those planning efforts involved several hundred Carmichael residents over a period of years. Community interest (As you on the CPAC are aware) in the quality of life in Carmichael has always been high and residents are keenly concerned about Carmichael having an identity and "Sense of Place". The historical founding of Carmichael as a rural farming community, together with our ZIP code as continued to keep the unique Community identification in place. As the Community evolves within a large unincorporated urban area the residents maintain that need for "Revitalization and Enhancement" as specified in these plans. The Board of Supervisors, particularly Supervisor Susan Peters, has consistently supported this Community goal by voting to spend considerably over a million dollars on the FOB Corridor Plan alone. Subsequently, the upgrade of FOB has breathed new life into the area.

Proposed projects, such as the two in review here, must not only be analyzed for consistency with appropriate regulations but also for the appropriateness, benefits and values to the Carmichael Community. While regulatory requirements can be mitigated or revised, the factors of benefits, values and negative impacts in the community must be considered.

In reviewing the projects I have looked at the need, demand, and value these projects would bring to the Carmichael Community.

- 1. The 24 Hour Gas Station and Convenience Store.
- A. The need for another gas station in this location is difficult to justify. There are three existing gas stations within a mile or so of this site (Two ARCOs and Safeway). In addition, there is a permanently closed (Valero within the last 5 years) gas station at Kenneth Ave. and FOB.
  - B. Traffic at this corner is significant. Adding the need for egress and exit to the area will only make it worse.
- C. Pedestrian use is heavy particularly from Carmichael School and adjacent apartments. In addition, this is not consistent with the objectives of the FOB Corridor Plan for increased pedestrian use
- D. Safety. As many others have stated we have all witnessed the increased crime issues in Carmichael at the existing nearby convenience stores (Two ARCOs, 7-11 at Marconi/Walnut). These facilities are documented as magnates for safety issues in the Community.
- E. Food Convenience. It's hard to believe that a convenience store is necessary. There are two supermarkets in close proximity (Belair and Safeway).

#### 2. The Off-Sale Liquor Permit

Again review of the need for liquor sales at this location as a value to the Community is questionable. There not only is a liquor store immediately across FOB; but two supermarkets (Safeway and Belair) very close by. Safety of the Community again is an issue with liquor sales locations. Even with conditions on sales the safety issue

cannot be mitigated.

During the past few years the economy has largely stifled the opportunities to invest in new developments along FOB. As we have slowly seen new business and development starts recently there still appears the desire to invest in businesses with little community value. Fair Oaks Blvd. is Carmichael's Main Street. We do not want FOB to continue to be just a a series of strip malls and fast food drive throughs.

The current situation and the short time frame for review, of course, makes it difficult for the residents to effectively provide input on these projects. I encourage you to consider holding additional review meetings on these projects.

I appreciate the CPAC's time and consideration and I encourage you to oppose approval of these two projects.

#### Dear Council Members:

I am writing to voice my opposition to the approval of a 24-Hour Automotive Service Station and the granting of a request for a Public Convenience and Necessity Letter for an Off-Sale Liquor License at 7300 and 7310 Fair Oaks Boulevard.

First let me say procedurally, there are two Sacramento County Planning Department signs at the proposed site. One sign is very visible on Sutter next to the sidewalk and states that the site will be developed with a Del Taco restaurant. The second sign is located on Fair Oaks Boulevard next to the existing building and has information about the proposed 7-Eleven gas station. The existence of the Del Taco sign creates undue confusion as to proper notice. (Exhibit A; four photographs of the two signs)

Also was timely notice of the hearing given to the San Juan Unified School District, since Carmichael Elementary School is located down Sutter Avenue and was notice given to the Carmichael Creek Neighborhood Association, since this project is in the Association's sphere of influence.

Professionally, I have maintained an office on Fair Oaks Boulevard since 1983. I have seen many changes to the Boulevard during that time. The County has spent many hours and hundreds of thousands of dollars conducting studies and developing plans to improve Fair Oaks Boulevard and the Carmichael community.

I also served for 4 years as a member of the Sacramento County Policy Planning Commission, which routinely considered proposals such as this one. CPAC Letter May 17, 2020 Page Two

I hope that each of you is familiar with the Fair Oaks Boulevard Corridor Plan that was adopted by the Board of Supervisors in 2011. If not, I would hope that the County Planner will discuss this plan in detail with you before you make any decision regarding these applications.

Long before the adoption of the Fair Oaks Boulevard Corridor Plan, there were many meetings that began before Supervisor Peters' tenure in office 16 years ago, when Muriel Johnson was the Supervisor.

The purpose of the Fair Oaks Boulevard Corridor Plan was "to help guide the revitalization and enhancement of Fair Oaks Boulevard..." (Exhibit B; Zoning Code of Sacramento County), Chapter 6, Administration, page 6-64)

The Zoning Code describes four distinct areas of Carmichael that were studied to create a template and guide for land uses in each of those areas. The subject application is in the East Fair Oaks Boulevard District. (Exhibit C is a copy of a map; Zoning Code of Sacramento County, Title VI, Chapter 11; Article 1, page 1-3)

The Main Street District, which extends from Marconi to Engle on Fair Oaks Boulevard, is a Special Planning Area. There are only limited uses in this area. For example a service station is prohibited in the Main Street District. (Exhibit D; Zoning Code of Sacramento County, Title VI, Chapter 11; Article 1, page 1-4)

The location of the property in question is one block outside of the Main Street District.

The Zoning Code goes on to state:

"The following regulations are intended to supplement the SPA regulations, and implement the principles of the Fair Oaks Boulevard Corridor Plan at a district level. These regulations will help transform this Section of Fair Oaks Boulevard and Manzanita Avenue into a vibrant mixed-use commercial and residential district with a mix of commercial and residential uses."

(Exhibit B; Zoning Code of Sacramento County, Chapter 6, Administration, page 6-64)

It is my belief that the proposed gas station and liquor sales <u>at this</u> <u>location</u> will not help transform this area of Carmichael into a vibrant mixed-use commercial and residential district.

Furthermore, the Development Standards of the Zoning Code go on to state: "Although not mandatory, projects outside of the Main Street District are encouraged to, and may at applicant's option, follow any or part of the development and design standards contained in the Fair Oaks Boulevard Corridor Plan. (Exhibit E; Zoning Code of Sacramento County), Chapter 6, Administration, page 6-65)"

Even though the foregoing paragraph seems to refer to the applicant, the same principles should apply to the CPAC. It is my opinion that, as members of CPAC, you should not make decisions solely on the basis of whether an application is legally permissible, but additionally on whether it is compatible with and an improvement to the community.

In addition the Zoning Code there is a Carmichael Community Action Plan that is an appendix to the Carmichael Community Plan. The Community Action Plan states, "[T]he actions contained in this CAP will result in guidance for many different agencies and departments within the County when adopting new plans and implementing existing ones" (Exhibit F; Carmichael Community Action Plan, Executive Summary, page 1).

Thus the CAP is specifically intended to be a guide for your deliberations and to influence your decisions.

The CAP under the section entitled Community Identity Goals states, "P1- Improve the **safety** and quality of life for the citizens of Carmichael" (Exhibit G; Carmichael Community Action Plan, Executive Summary, page 2).

As some of the members of the Council know, I have been the chair of the Carmichael Improvement District Safety and Property Committee for more than 2 years. This committee meets once a month to discuss safety and security issues in Carmichael. Usually there are over 30 people who attend this meeting including two Sacramento County Deputy District Attorneys,

two California Highway Patrol Officers, four or more Sacramento Sheriff's Department Deputies, a Sacramento County Code Enforcement Officer, a representative of the private security company that patrols the Carmichael Improvement District 7days a week-12 hours a day one or two members of CPAC, and members of the public. The Carmichael Improvement District pays its private security company more than \$160,000 a year to try to make Carmichael safe.

At these monthly Security meetings crime and homeless issues are discussed with an exchange of information between the different agencies. Every day I receive by email a written report from the Carmichael Improvement District security company that informs me of every incident

that the security company encountered the prior day. Without a doubt the two AM-PM gas stations in the District are a major source of crime and homeless issues. It is not the fault of the gas stations, but it is just because of the type of business it is. A 24 hour gas station that sells liquor attracts loitering, drug and other criminal activity and commonly creates litter, unsanitary conditions and other forms of public nuisance.

Another gas station in Carmichael that sells liquor will only compound and exacerbate the crime and safety problems. Thus when deciding this application, the Council should consider the issue of safety as addressed in the Carmichael Community Action Plan.

The Carmichael Community Plan also addresses the types of businesses that are desirable for Carmichael:

"C4: An effort should be made to actively recruit businesses that will enhance Carmichael such as restaurants, boutiques, and businesses that are oriented to families."
(Exhibit H; Carmichael Community Action Plan, Neighborhood Services Policies, page 4).

Another gas station in Carmichael that sells liquor is not a business that enhances the business community nor is it oriented to families.

Sacramento County spent approximately \$1,000,000 conducting the studies mentioned in this letter. Many hours of planning department reasoned thought and community input went into the creation of these studies. The approval of these pending applications will only serve to undo the years of effort made to improve the quality of business and everyday life for the residents of Carmichael.



# 6.7. FAIR OAKS BOULEVARD CORRIDOR PLAN

# 6.7.1. Purpose

The Fair Oaks Boulevard Corridor Plan was adopted in 2011, to help guide the revitalization and enhancement of Fair Oaks Boulevard, between Oak Avenue and Marshall Avenue, and Manzanita Avenue between the Boulevard and Winding Way. This 3-mile stretch of Fair Oaks Boulevard and Manzanita Avenue is Carmichael's economic and social center. Since its early days as the main street for Carmichael Colony, the Boulevard has provided a wide range of community services, including discount retailing, auto repair, convenience commercial centers, and food. Over time, the street also became a regional road, and has several generations of older commercial development that cannot compete with large contemporary commercial centers.

The corridor planning area also includes a Special Planning Area (SPA) for the Main Street District. The following regulations are intended to supplement the SPA regulations, and implement the principles of the Fair Oaks Boulevard Corridor Plan at a district level. These regulations will help transform this Section of Fair Oaks Boulevard and Manzanita Avenue into a vibrant mixed-use commercial and residential district with a mix of commercial and residential uses.

#### 6.7.2. Applicability

The boundaries of the Fair Oaks Boulevard Corridor Planning Area are shown in Figure 6-1.


### 6.7.3. Special Provisions

Relating to East Fair Oaks Boulevard, Manzanita and South Gateway Districts of the Fair Oaks Boulevard Corridor Planning Area.

### 6.7.3.A. Permitted Land Uses

Land uses permitted within the East Fair Oaks Boulevard, Manzanita and South Gateway Districts of the Fair Oaks Boulevard Corridor Planning Area shall be those uses permitted in the underlying zoning district, except as set forth in Section 6.7.3.A.1 through 6.7.3.A.10, and shall conform to the development standards as set forth in the Zoning Code. The following uses, if otherwise permitted in their respective zoning district, shall require a Conditional Use Permit from the County Planning Commission:

- 1. Liquor Store.
- 2. Check Cashing Stores.
- 3. Tobacco Shop.
- 4. Gun shop-Gunsmith.
- 5. Storage Building—Mini.
- **6.** Machine Shop, Photographic Processing Plant-wholesale Facility, Building Trades Service Yard and Workshop.
- 7. Thrift/Second Hand Stores, excluding incidental sales of second hand items.
- 8. Recycling Centers.
- 9. Tattoo Parlors.

# 6.7.3.B. Development Standards

- 1. All development projects, including land use entitlements and building permits for new and renovation construction, proposed within the East Fair Oaks Boulevard, Manzanita, and South Gateway districts of the Fair Oaks Boulevard Corridor Plan shall be subject to the County's Design Review program, per Section 6.3.2 of this Zoning Code. Although not mandatory, projects outside of the Main Street District are encouraged to, and may at applicant's option, follow any or part of the development and design standards contained in the Fair Oaks Boulevard Corridor Plan.
- 2. Development projects proposed within the East Fair Oaks Boulevard, Manzanita and South Gateway districts of the Fair Oaks Boulevard Corridor Plan may, at the applicant's option, utilize the alternative development and design standards, as described in the Fair Oaks Boulevard Corridor Plan instead of the development and design standards contained in the Zoning Code. The County DRA is authorized to approve any projects pursuant to Section 6.7.3.B.1 or pursuant to the development standards and design concepts as described in the Corridor Plan. Any projects that include residential components which exceed certain intensity requirements of the Fair Oaks Boulevard shall be forwarded to the County Planning Commission or appropriate hearing body for final review and approval, as described in the Review Process for the Main Street District SPA.
- 3. When major new development or major redevelopment of a site occurs, improvements in the public right-of-way and/or landscape setback areas shall conform to the streetscape design concepts and principles in Section 2.6 of the Fair Oaks Corridor Plan.
- **4.** General nonconforming, remodeling and demolition of nonconforming uses within the East Fair Oaks Boulevard, Manzanita and South Gateway Districts shall be dictated by the following provisions:

Nonconforming use in an existing building (use/business previously permitted by right requires Conditional Use Permit pursuant to this ordinance). The use/business may continue to operate indefinitely, or the same type of business/use may reoccupy the premises, as long as the vacancy period does not exceed 18 months for properties located in the East Fair Oaks Boulevard, Manzanita and South Gateway Districts. Extensions of the vacancy period may be approved by the Planning Commission.

# **EXECUTIVE SUMMARY**

**Purpose**: The adopted Community Action Plan (CAP) is an appendix to the Carmichael Community Plan. This CAP covers more than just land use as is typical in a community plan. The purpose of doing an Action Plan was to increase community involvement in planning and service delivery. The actions contained in this CAP will result in guidance for many different agencies and departments within the County when adopting new plans and implementing existing ones.

Types of Actions: The CAP contains three types of actions.

- On-going actions are currently underway by the County. Typically, these actions
  are already in the work plan of the department, have a budget and staffing.
- Short-term actions are new programs or policies that will be implemented within a two-year time frame. Typically these actions are easy to implement, do not have significant costs and will be included in near-term work plans and budgets.
- Long-term actions are new programs or policies that will be implemented after
  two years. Although some actions will be in the short-term, they may take longer
  than two years to implement. These long-term actions are typically items that
  could be costly to implement or need further review and study to determine costs.
  They will be considered in both near-term and future work plans and budgets.

**Further Review and Revisions**: The Community Council (or other appropriate authority) and the Board of Supervisors will review the Community Action Plan annually to determine the status of the action. Additionally, the long-term actions will be analyzed to determine if it is time to begin work on them. Items that were originally deferred will be reassessed to determine if it is time to develop actions to accomplish those items. The Community Council may choose to survey the community, either formally or informally to assess whether or not deferred items should be further addressed.

As part of the annual review, the hearing authority will determine if the actions need to be modified or eliminated due to changes in County policies or programs.

Policies Endorsed by the Community: The Carmichael community was invited to participate in the preparation of the Community Action Plan. The early phases of the process resulted in the identification of issues that were important to the community.

<u>Goals</u>: From these issues, participants were to consider the following goals in determining solutions to those issues:

# Neighborhood Services Goals

- N1- The County will be responsive to neighborhoods.
- N2- The County will more actively involve residents in the ongoing shaping of their community through different means of governance and community involvement.

# **Transportation Goals**

- T1- The County will continue to pursue the implementation of the Circulation Element of the General Plan.
- T2- The County will continue to work with the Carmichael community and Regional Transit regarding the strategies that are under Regional Transit's control.
- T3 The County will investigate and, where appropriate, install bike lanes according to the City/County Bikeway Master Plan.
- T4 The County will install sidewalks at high priority locations.
- T5- The County will work with neighborhoods/SMUD to identify locations where the installations of streetlights are desired.

# **Community Identity Goals**

- C1- Create a distinct and identifiable community identity for Carmichael.
- C2- Create an attractive and revitalized business district that is oriented to serving the residents of Carmichael.

# Land Use Goals

L1- Identify policies and strategies for using land use planning and decisions to preserve the character of Carmichael.

# **Public Safety Goals**

P1- Improve the safety and quality of life for the citizens of Carmichael

<u>Policies</u>: The actions contained in the Community Action Plan support these goals and implement the policies that were endorsed by the Carmichael community and the Board of Supervisors. These policies listed below resulted from the survey of the community. The questions from the survey are noted in Appendix A.

# Neighborhood Services Policies

- N1: Work with local park districts to help sponsor and organize festivals, farmer's markets and other community events at area parks and the community centers. (Survey Question #26)

I am sending this email to voice my objection of 7-11 at the corner of Sutter and Fair Oaks. Since I believe you want to improve the quality of life in Carmichael, just as I do, I hope you will join me in opposing a proposed 24 hour 7-Eleven gas station, convenience store, and liquor sales that is to be built on the northeast corner of Sutter and Fair Oaks Blvd.

For 2 1/2 years the Carmichael Improvement District has hired a security company to patrol the District 12 hours a day 7 days a week. I attend these meetings regularly. The majority of incident reports, cite that the two AM-PM gas stations that currently exist in Carmichael, are magnets for crime and homeless issues. The security company has had to respond to these two existing gas stations more than most other businesses.

The addition of another gas station in Carmichael will only exacerbate the problems that Carmichael has to contend with. I am not against gas stations, just where this one will be located. As to the need for a liquor store, there is already a liquor store across the street from this location as well as Big Lots and Smart and Final, who both sell alcohol. I live very close to this area and in the 11 years I have lived in Carmichael, I have seen the homelessness and crime rise.

The County 17 years ago or so spent around one million dollars conducting studies to improve the appearance of Fair Oaks Boulevard in Carmichael with the expectation that those improvements would attract quality businesses. One study looked at Carmichael being four distinct areas. It also recommended what type of business should be located in each area. Automotive businesses were to be located around the area of FOB and California, not in the heart of Carmichael. A gas station at Sutter and FOB is not a compatible use for that part of Carmichael. I saw in my Carmichael Facebook watch group that there is a 24-hour 7-11 with gas station being proposed for the corner of Sutter & Fair Oaks. I want to express my opinion that this is not a good idea for the neighborhood for several reasons:

- 1) That corner and surrounding areas have already become magnets for transients and crime. I recently got aggressively panhandled at the dry cleaner across the street and will never go back. I believe a 7-11 will attract the wrong element, especially late at night. In fact, I believe that it could negatively affect other businesses already in the close proximity, such as La Bou and the spa nearby. The kind of businesses we need more of in Carmichael.

As a longtime Carmichael resident (30 years this summer) I am writing to **OPPOSE** the approval for a 24 hour 7-Eleven gas station, convenience store with liquor sales proposed for the northeast corner of Sutter and Fair Oaks Blvd. My reasons are as follows:

1) There are already 2 gas stations (Arco and Safeway) within 1/3 mile of the proposed site (with one on each side of Fair Oaks Blvd.). History has shown that gas stations have the potential to pollute the ground, aquifers and air. We do not need to add to the possibility of more exposure to these contaminants when other existing businesses are already

accessible to the public.

- 2) There are already 2 groceries stores (Bel Air and Safeway) within a 1/4 mile of the proposed site (with one on each side of Fair Oaks Blvd.) But for the current Covid19 SIP orders, both these businesses have extended hours that meet the needs of Carmichael residents to purchase food, and other essential and non-essential items (including cigarettes and liquor).
- 3) The corridor between Marconi Ave. Fair Oaks split and Manzanita Ave. is already one of the most congested roads in Carmichael. We do NOT need to add to this congestion, especially given the existing businesses outlined above. The egress, in and out of a narrow street like Sutter, will only add to the current traffic concerns. Also, there is already a Starbucks within 1/3 miles of the proposed site (same side of the street) that has resulted in more traffic congestion, which sells some of the same things as a convenience store would.
- 4) Having a convenience store within one long block of Carmichael Elementary School is an attractive nuisance. Increased traffic and the junk food that children are attracted to after school does nothing to enhance the community, and posses a hazard by way of the increased traffic to students walking to and from school.
- 5) There is absolutely NO need for a store that sells goods 24/7; such a business often attracts the unsavory in our communities. This makes the entire town of Carmichael vulnerable to individuals who engage in nefarious activities from the hours of 12 midnight to 5:00 am, There is no denying that petty crimes have increased exponentially in Carmichael in recent years. We do not need to approve a business that will create attractive nuisances to our safety.
- 6) The County of Sacramento has already suggested that this is NOT a compatible use for this location Carmichael.

I am a resident of Carmichael, in the Lincoln / Barrett Hills neighborhood.

Some online postings on Facebook and Nextdoor claim that there is a proposed development at the northeastern corner of the Sutter Avenue / Fair Oaks Blvd. intersection. The postings state that the proposed development is a 7-Eleven, with a gas station, convenience store, and liquor sales.

I have not seen such plans, and do not know if the information is correct. However, if the postings are correct, I would like to register my opposition to the proposed plan. Fair Oaks Blvd., in my view, needs more businesses like the Milagro Center that was developed a couple years ago -- businesses that elevate Carmichael not just aesthetically, but also economically. Another gas station / convenience store is redundant, and adds nothing to Carmichael's profile. Given the availability of existing gas stations and stores, it would bring very little incremental benefit to those of us who live here.

More generally, I urge the Board of Supervisors to pay more attention to the economic development goals of unincorporated areas like Carmichael. I have been a resident of the Carmichael neighborhood where the proposed convenience store is located for 36 years. During that time, we have strived to maintain our community's sense of place and to improve the commercial zone on Fair Oaks Boulevard, our "Main Street." I believe that the proposed 7-Eleven store runs contrary to our decades-long efforts and continuing investment in the corridor.

We don't need another gas station since there are three existing stations within a mile or so of the proposed site. Additionally, at the corner of Kenneth and Fair Oaks Boulevard, is a former Valero gas station that has become an eyesore and magnet for homelessness and trash accumulation.

A convenient store would add significant traffic as customers enter and leave the business at that corner. I have not seen such plans, and do not know if the information is correct. However, if the postings are correct, I would like to register my opposition to the proposed plan. Fair Oaks Blvd., in my view, needs more businesses like the Milagro Center that was developed a couple years ago -- businesses that elevate Carmichael not just aesthetically, but also economically. Bill we have been in contact with DWR and have gotten their response to the letter. They did an
extensive preliminary review of the site and are comfortable with the proposed drainage plan. They
will be conducting a further reviewing during the improvement plan phase. There are protective
measures in the conditions to address noise and dust. Because of the drainage easement there will
be no construction near the person property line. As for the anchor of the utility pole. It is a SMUD
pole and they have commented that they are not in favor of relocating the apparatus and it can
remain in the easement.

Below are responses from our Project Manager to the comments received.

- Scott Berry project will add traffic to already congested/narrow street, will demand speed bumps on Turnbull Circle if project is approved.
  - o The project will add 11 new single-family residential structures on the subject parcel (in addition to the 1 existing single-family structure on site). DOT's trip generation estimates 113 daily trips, with 12 PM peak trips being generated by the project. This did not warrant a traffic study for the project. The project's increase in traffic experienced on Turnbull Circle is minimal.
  - o In regards to speed bumps on Turnbull Circle, DOT has not identified this as a condition of approval for the project. However DOT has program (Neighborhood Traffic Management Program), a resident-driven project, in which residents can petition for a street to be treated with traffic-calming features, such as speed bumps. This info can be provided to the commenter.
- Angela Nicholas shares a property line with proposed Lot 1, concerns expressed include: traffic, floodplain, drainage easement, and utility pole impacts.
  - o In re: traffic created by project, see bullet 1 under Scott Berry.
  - o Impacts to the floodplain project does not involve construction in or permanent structures to be located within the existing floodplain area.
  - o Drainage easement the purpose of the drainage easement on proposed Lot 1 is to route local drainage across Lot 1 with an overland release path towards the existing drainage channel. The drainage easement will not result in noise, dust, or debris impacts to the commenter as suggested. No trees along the commenter's shared proposed line with Proposed Lot 1 are proposed to be removed. Steve (CNA) can speak to the existing drainage in the project area.
  - o In regards to construction-period noise/dust impacts, Condition No 5 requires the installation of privacy screens/fencings prior to construction activities associated with the project.
  - o In re: the utility pole on her property, this utility pole is supported by a wire that is anchored into proposed Lot 1. SMUD is requiring all existing utilities to remain in place, and the project is not proposing to alter this anchor.

I am writing in strong opposition to approval in any form of the Items 2 and 3 (PLNP2019-00261 and PLNP2019-00262) on the May 20, 2020 CPAC agenda.

I have been a resident of Carmichael since 1979. During this period of time I have been very active in volunteering and supporting my Community, serving on the Carmichael Park Board, and the Carmichael Colony Neighborhood Association. In addition, I served as Chairman of the Carmichael Community Action Plan (CCAP) effort and also on the Carmichael Planning Council during preparation of the Fair Oaks Blvd. Corridor Plan.

Those efforts resulted in these current active planning documents and subsequent zoning regulations for Carmichael. The preparation of those planning efforts involved several hundred Carmichael residents over a period of years. Community interest (As you on the CPAC are aware) in the quality of life in Carmichael has always been high and residents are keenly concerned about Carmichael having an identity and "Sense of Place". The historical founding of Carmichael as a rural farming community, together with our ZIP code as continued to keep the unique Community identification in place. As the Community evolves within a large unincorporated urban area the residents maintain that need for "Revitalization and Enhancement" as specified in these plans. The Board of Supervisors, particularly Supervisor Susan Peters, has consistently supported this Community goal by voting to spend considerably over a million dollars on the FOB Corridor Plan alone. Subsequently, the upgrade of FOB has breathed new life into the area.

Proposed projects, such as the two in review here, must not only be analyzed for consistency with appropriate regulations but also for the appropriateness, benefits and values to the Carmichael Community. While regulatory requirements can be mitigated or revised, the factors of benefits, values and negative impacts in the community must be considered.

In reviewing the projects I have looked at the need, demand, and value these projects would bring to the Carmichael Community.

#### 1. The 24 Hour Gas Station and Convenience Store.

- A. The need for another gas station in this location is difficult to justify. There are three existing gas stations within a mile or so of this site (Two ARCOs and Safeway). In addition, there is a permanently closed (Valero within the last 5 years) gas station at Kenneth Ave. and FOB.
- B. Traffic at this corner is significant. Adding the need for egress and exit to the area will only make it worse.
- C. Pedestrian use is heavy particularly from Carmichael School and adjacent apartments. In addition, this is not consistent with the objectives of the FOB Corridor Plan for increased pedestrian use
- D. Safety. As many others have stated we have all witnessed the increased crime issues in Carmichael at the existing nearby convenience stores (Two ARCOs, 7-11 at Marconi/Walnut). These facilities are documented as magnates for safety issues in the Community.
- E. Food Convenience. It's hard to believe that a convenience store is necessary. There are two supermarkets in close proximity (Belair and Safeway).

#### 2. The Off-Sale Liquor Permit

Again review of the need for liquor sales at this location as a value to the Community is questionable. There not only is a liquor store immediately across FOB; but two supermarkets (Safeway and Belair) very close by. Safety of the Community again is an issue with liquor sales locations. Even with conditions on sales the safety issue cannot be mitigated.

During the past few years the economy has largely stifled the opportunities to invest in new developments along FOB. As we have slowly seen new business and development starts recently there still appears the desire to invest in businesses with little community value. Fair Oaks Blvd. is Carmichael's Main Street. We do not want FOB to continue to be just a a series of strip malls and fast food drive throughs.

The current situation and the short time frame for review, of course, makes it difficult for the residents to effectively provide input on these projects. I encourage you to consider holding additional review meetings on these projects.

I appreciate the CPAC's time and consideration and I encourage you to oppose approval of these two projects.
