**WHEREAS**, **TINA MACUHA** is a native of Sacramento and graduated from California State University, Sacramento with a double major in Communications and Geography; and

**WHEREAS**, **TINA MACUHA** started working in radio after college and was on the morning show of Sacramento's FM 102 in the early 1990's spending a total of 12 years on the radio waves before transitioning to her current television home on "Good Day Sacramento;" and

**WHEREAS**, **TINA MACUHA** can be seen every morning on the television screen reporting during commute hours and provides engaging appearances by sharing with the viewing audience her "Thought of the Day," awarding a free lunch called the "Grub Run" to a lucky office and asking the "Question of the Day" to share insight about her broadcast co-workers plus testing their knowledge of music during the segment known as "Teen's Tune;" and

**WHEREAS**, the mother of **TINA MACUHA** died from breast cancer in 1983 and Tina herself is breast cancer survivor and shared her personal story on the air in 2009 and continues to this day to provide education, hope, and courage to others at many breast cancer events and fundraisers.
