RESOLUTION OF THE BOARD OF SUPERVISORS,
COUNTY OF SACRAMENTO, STATE OF CALIFORNIA,
HONORING DR. ROBERT MOYNIHAN
FOR HIS SERVICE AS A MEMBER OF THE SACRAMENTO COUNTY
MATERNAL, CHILD AND ADOLESCENT HEALTH ADVISORY BOARD

WHEREAS, on this 5th day of December, 2017, DR. ROBERT MOYNIHAN is being recognized for his more than 11 years of dedicated service to the people of Sacramento County as a member of the SACRAMENTO COUNTY MATERNAL, CHILD AND ADOLESCENT HEALTH ADVISORY BOARD (MCAH ADVISORY BOARD); and

WHEREAS, DR. MOYNIHAN is a 1983 graduate of the University of Massachusetts Medical School, where he earned a degree in Medicine. Additionally, in 2005, he received a degree in Medical Acupuncture from the University of California, Los Angeles, David Geffen School of Medicine, and in 2017, was awarded the Functional Medicine Certificate from The Institute for Functional Medicine; and

WHEREAS, during DR. MOYNIHAN's tenure on the MCAH ADVISORY BOARD, he was instrumental in the review and formation of numerous recommendations on a variety of projects and programs serving people throughout Sacramento County, including the MCAH Five-Year Assessment Plan, the County of Sacramento Community Health Status Report and the Geographic Managed Care Denti-Cal Program. He also was a strong voice in advocating for funding supporting public health programs, including the Nurse Family Partnership, and worked diligently on the revision of the MCAH ADVISORY BOARD Bylaws; and

WHEREAS, DR. MOYNIHAN served as Chairperson of the MCAH ADVISORY BOARD for more than 10 years, from May 2007 through December 2017. During his years of service, DR. MOYNIHAN gained the respect of fellow board members, public health staff, community representatives and concerned residents, and was known for his thorough, deliberate and conscientious approach to public health issues, especially for the focus he brought to assuring that health and social programs and policy utilize the social determinates of the health framework in addressing community health and well-being issues. DR. MOYNIHAN also served on the Nurse Family Partnership Community Advisory Board where he championed the program and its continued sustainability; and

WHEREAS, DR. MOYNIHAN brought a wealth of knowledge and expertise related to health and well-being issues, having served as Founder and Medical Director of Pediatric & Anesthesiology emeritus for Sutter Medical Center, Sacramento. He also served as a member of a five anesthesia physician system-wide team charged with developing for 27 Sutter Health Affiliates, an Anesthesia Perioperative Electronic Health Record (EHR) system, and for 24 years, he served as a Pediatric Anesthesiologist partner with the CASE Medical Group.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors, County of Sacramento, State of California, does hereby extend its commendation to DR. ROBERT MOYNIHAN for his many years of dedicated service in serving as a member of the SACRAMENTO COUNTY MATERNAL, CHILD AND ADOLESCENT HEALTH ADVISORY BOARD; and further, offers its sincere thanks and appreciation to DR. MOYNIHAN in recognition of his numerous contributions, hard work and tireless efforts in serving the people of Sacramento County; and finally, extends best wishes to DR. MOYNIHAN for good health, much happiness and many blessings in the years to come.

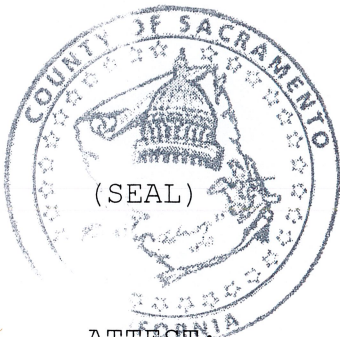
